### *It's Showtime Once Again for the Sixth;* **VEGAS 'STRIP' TO HOST MARINE EXTRAVAGANZA**

Las Vegas is once again ready for the Sixth Division Marines, this time at the Sahara Hotel, one of the prime entertainment hotspots at the center of the "Strip," that legendary home of party-going hospitality known to reenergize aging veterans who didn't know they still had it in them.

Susan Parham and Marilyn and Martin Essex have put it all together for your Reunion enjoyment beginning Sunday 9-25-05 when registration begins. It won't be over until Friday checkout at noon on 9-30-05. The weekdays Reunion is a result of Vegas hotels going money-crazy on the weekends. That's when they haul in the big bucks.

Weekdays at the Sahara are not all that bad. The hotel is a Las Vegas landmark but still thrives. It has recently been redecorated with a Moroccan theme in keeping with its desert namesake. Any husband who has ever dreamed of being a wild and woolly Sheik, now's your chance. Any wife who has ever thought it might be nice to have a wild and woolly husband, likewise.


A special rate of \$65 a night single or double occupancy for the Reunion has been arranged. Those wanting to stay for the weekend will have to pay \$109 a night. Deadline for registration is August 5. Checks only will be accepted; no credit cards.

The hotel's 1760 rooms, restaurants and other dining options, spa, salon and shopping outlets are just part of the offerings there. There is the casino and there will be live entertainment in the famous Congo Room and the Casbah Room. Remember the 1938 movie "Algiers," where the French cops chase Charles Boyer around the Casbah while he's trying to make out with Hedy Lamarr. Probably, we are among the few left who might remember it, him and her. Wasn't she a beauty though?

Sahara rooms provide high-speed Internet access for those who bring their computers. There is also a 5,000 square foot pool with eight cabanas, a bar and snack bar. Valet or self-parking is available.

There are other amusements on the "Strip" besides the Sahara. There are, to name a few of the casinos, the Las Vegas Hilton, Convention Center, Harrah's, the Flamingo, Bally's, Paris and MGM Grand. There are also bars, nightclubs and restaurants. Off the "Strip" are other casinos, including the Bellagio, the Rio and Steve Wynn's brand-spanking new Steve Wynn Hotel and Casino.

Despite the mountain Spangler had to climb getting everything ready by her self imposed April 1 deadline, she got it all done but the printing when the project ran into a wall in March. Quite simply, the printer, who had agreed to help out at cost, wanted assurance that he would be paid. Can you imagine that?

So far, no major expense had come up, thanks to all the free labor, but no provision for seed money to pay the printing bill had been made. Oops!

When the project was announced at the Nashville Reunion, no one had any idea even of how many pages would be required, much less the cost of paper, color, art, reproduction, all of the expense involved in modern day publishing. Spangler had published a cookbook before, but that was then, this is now.

It would take \$5,000, she found, to have books ready to sell. She turned to the association for seed money. Jean Steed, who had been mothering the Sons and Daughters, of which Spangler is one, had been dealing with the death of her father, Dan Dereschuk, and the emotional and practical details that involves.

President Andrew Sinatra had just put his wife in the hospital following a sudden emergency when he was informed. That just about capped his day, but he responded.

Sinatra said that he personally approved of the expenditure but that he couldn't authorize it without violating the bylaws. He believed he had to consider the will of the membership and couldn't give an immediate answer.

Things simmered for a while as Spangler considered having a stroke, the newsletter was held up and various members considered possible solutions. The problem finally boiled down to should the association wait for a vote at the upcoming Reunion or conduct a tele-

phone poll of the Executive Committee or of the full board.

Holding off until the Reunion would kill any sales this summer and would mean no sales at the Reunion. It might also dampen the desire of any Sons and Daughters, including Spangler, to ever again want to do anything for this association.

Another point made: Providing the seed money didn't mean that it was gone forever. Some is bound to come back, maybe most or all, maybe considerably more. The money would pay for 1,000 books. If all of them sell, it's money in the bank.

On the other side, \$5,000 is a lot of money, due consideration should be given and the matter should have been decided before now.

Past President John J. Foley and Sinatra broke the logjam. They mutually determined that the full board should decide, and they should do so immediately. Rev. Frank Mack, our new chaplain, should conduct the poll. What could be fairer than that?

Mack reported back that an overwhelming majority favored providing the \$5,000 in time for Spangler to keep her April 1 deadline and begin selling books.

Sinatra breathed a sigh of relief and said that his wife was doing better. Foley said he was glad he didn't have to court martial anyone.

# MINUTES - 2004 NASHVILLE MEETING

Meeting called to order by President Andrew Sinatra Sept. 30, 2004. Opening prayer by Chaplain Claud Wilkins followed by Pledge of Allegiance. Secretary's report was dispensed as it was published in the June newsletter. Treasurers report was read by the Secretary as the Treasurer had to leave the Reunion, following an emergency at home. The report stated that we had a total of \$74,582.75 in our treasury. This report was accepted as read.

Chaplain's report: List of deceased to be updated. Reverend Frank Mack, a member of the association, was asked if he would accept the position as Chaplain to replace Claud Wilkins, who had resigned. He agreed. Claud Wilkins received a new title: Chaplain Emeritus.

Newsletter Editor: It was decided to publish three newsletters per year consisting of twelve pages each; issue dates to be left to the editor's discretion.

Year 2005 Reunion Chairman: Martin Essex has notified the body that the hotel selected for the 2005 Reunion was to be announced later as he has a choice of his selection. The tentative dates are 25 September to 30 September, 2005.

A discussion was held relative to the 15th Marines, 22nd Marines and the Raiders holding their reunions along with the Sixth Division Reunion instead of separately. These organizations, many of whose members belong to our association, hold their reunions at different locations and usually different dates.

Sons & Daughters: Jean Steed who is the Chairperson and Liaison officer of this organization stated that a cook book was being put together by the members and profits would be given to the association. More to follow.

Nominating Committee: John Foley stated that Tom McKinney had submitted his name for President. Tom Terpinas of the nominating committee recommended that since the current president had not served the entire year, following the resignation of Buzzy Fox, the current president's term should be extended for another year. This was voted on and passed. After a lengthy discussion Andrew Sinatra was reelected as President of the Association for 2004-05. Harold (Pete) Howell was voted in as President-elect.

15TH: THE WORLD WAR II  
DEDICATION.

Another highlight of the World War dedication weekend was getting to share it with members of the 15th Marines Association. The 15th gathered to be a part of the dedication weekend for a mini-reunion in Washington, Memorial Day 2004. They spent their first day at Quantico Marine Corps Base and had a memorable day.

Friday began at the Sixth Marine Division Memorial at Quantico National Cemetery. A base chaplain helped them pay tribute to comrades who will forever be young, and to remember others present at the memorials dedication in April of 2000, who have since passed on. They admired the memorial and honored DeWitt Joralemons for his hard work as the memorial chairman. The trees and shrubs at the memorial are maturing and a nice spring made the setting a delight.

Next the group headed to the Gray Research Center where members of the Marine Corps University Archives had prepared a special program for them. The group was treated to a presentation in the facilities auditorium, complete with music from the forties, and best, a surprise! Al Garcia and Bill Sams recognized themselves in one of the photographs used in the program. Both men stood at the same time and yelled "Hey that's me, that's my gun!"

The presentation brought back many memories and was followed by the unveiling of a new display that the author had prepared in the foyer of the center. The display—a table display and a full wall display of the Sixth Marine Division, will be a focal point of the entryway from now on at the center. Members of the 15th found this a fitting tribute to the men of the Striking Sixth.

Lunch was served in the chow hall where the old veterans of the Second World War had the opportunity to meet some of the new veterans from Iraq and Afghanistan. Almost daily, new comments or questions are posted by visitors. These postings may be read or replied to by one and all. One may also directly email the poster.



# Chaplain's Column

Greetings from your new Chaplain. Please allow me first to introduce myself. I was born on February 12, 1926 and still live in Mercer County, Illinois, only about 30 miles from my birthplace. Following graduation from high school in 1943, my military service began when I enlisted in the U.S. Navy at the age of 17. I went through boot camp and hospital corps school at Great Lakes Naval Training Station. So as not to bore you with details, I will mention only the highlights of my service with the Marine Corps.

While stationed at the San Diego Naval Hospital in January 1944, I volunteered for the Fleet Marine Force and was sent to Marine Combat Medical School. In September 1944 I was attached to the newly formed Sixth Marine Division and subsequently assigned to the 22nd Regiment as a hospital corpsman. I served as a line corpsman with K Company during the battle of Okinawa and received shrapnel wounds on May 15, 1945 during the battle for Sugar Loaf Hill.

While most of you went to Tsingtao, China when the war ended, I was reassigned to the Navy and went to Japan. I spent the next five months aboard ship as part of the occupation forces. Following my discharge from the Navy in January 1946, I attended college on the GI Bill while being employed as a civilian by the U.S. Army, Corps of Engineers. After 35 years of employment with the Rock Island District, USACE, I retired in 1981 as Chief of the Emergency Management Division.

I entered seminary training in 1981 and was ordained as a minister in the Christian Church (Disciples of Christ) in 1984. Since that time I have served as a pastor and hospital chaplain, as well as a pastoral care counselor. Currently and for the last nine years I have been serving as the Chaplain of the 22nd Marines Association.

My wife, Nancy, and I have collectively, been blessed with three sons and two daughters. We have 15 grandchildren, nine boys and six girls, ranging in age from three
